SWEEPSTAKES DESCRIPTION: Solarity Credit Union is celebrating the launch of its upgraded digital banking platform with a four-week Sweepstakes featuring Weekly Cash Prizes. Members can enter by logging in to online banking or the mobile app and completing a daily entry form.

PRIZES: Sweepstakes Sponsor will award three (3) \$100 cash prizes each week during the Sweepstakes Period. Limit one Weekly Cash Prize per household per week. Sweepstakes Sponsor retains the right to substitute prizes with a Gift Card or Cash of equal value at Sweepstakes Sponsor's sole discretion. Terms and conditions may apply. Incidental expenses and all other costs and expenses which are not specifically listed as part of a prize in these Official Rules and which may be associated with the award, acceptance, receipt and use of all or any portion of the awarded prize are solely the responsibility of the respective Prize Winner. **ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZE ARE SOLELY THE RESPONSIBILITY OF THE PRIZE WINNER.**

SWEEPSTAKES PERIOD: The Sweepstakes begins Monday, July 21, 2025, and ends on Sunday, August 17, 2025. The Weekly Contest Periods are defined as follows: Week 1 begins on July 21 and ends on July 27; Week 2 begins on July 28 and ends on August 3; Week 3 begins on August 4 and ends on August 10; Week 4 begins on August 11 and ends on August 17.

ELIGIBILITY: The Sweepstakes is open to all U.S. residents who successfully fulfill the requirements of entry and who are at least eighteen (18) years of age. See the "Restrictions" section in these Official Rules for any eligibility restrictions. By entering this Sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of Solarity Credit Union. Entrants may be asked to provide proof of eligibility to enter.

PARTICIPATING LOCATION: The Sweepstakes is offered at Solarity's location listed in the Sweepstakes announcement. No other Solarity locations are participating in this Sweepstakes.

SWEEPSTAKES ENTRY: There are two ways to enter:

- **Method #1: Digital Banking Entry.** Log in to online banking or the Solarity mobile app and click on the Sweepstakes banner ad to access the daily entry form. Limit one (1) entry per person per day. Entries received during each Weekly Contest Period will be eligible for that week's drawing only.



- **Method #2: Alternate Method of Entry ("AMOE").** To receive one entry into the Sweepstakes without logging in to Solarity online banking or mobile app, print your full name, complete home address, email address, phone number, age and "Digital Banking Upgrade Sweepstakes" on a 3 x 5-inch piece of paper. Send it by United States Postal Service mail in a sealed envelope no larger than 9½" x 4¼" (a #10 envelope) with correct postage to: Solarity Credit Union – Digital Banking Upgrade Sweepstakes, ATTN: Marketing, PO Box 2922, Yakima, WA 98907. Each mailed entry must be submitted separately, postmarked during the Sweepstakes Period, and received by Thursday, August 21, 2025. Entries received during each Weekly Contest Period will be eligible for that week's drawing only. Limit one (1) entry per person per business day. Photocopied, illegible or mechanically reproduced entries are not eligible. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

All methods of entry have an equal chance of winning. All entries become the sole property of the Sponsor and will not be acknowledged or returned.

PRIZE WINNER SELECTION: Weekly Prize Winners will be randomly selected from eligible entries received during each Weekly Contest Period. Entries do not carry over from week to week. For example, entries submitted in Week 1 will only be eligible for that week's drawing and not for subsequent weeks. Weekly Prize Winners will be determined and notified as follows: Week 1 = July 28, 2025; Week 2 = August 4, 2025; Week 3 = August 11, 2025; Week 4 = August 22, 2025. Individuals need not be present to win. Sweepstakes Sponsor will notify Prize Winners by telephone, email or postal mail using the contact information supplied within the Sweepstakes Entry. It shall be the responsibility of entrants to provide contact information within their Sweepstakes Entry in order to be eligible to collect the prize. Prize Winners may be asked to provide proof of eligibility.

ODDS OF WINNING: The odds of winning depend on the total number of qualified entries submitted.
