



Solarity Credit Union's ("Credit Union" or "Sponsor") April Get-Away Give-Away Sweepstakes ("Sweepstakes") is governed by these Official Rules. By participating in the promotion, each entrant agrees to these Official Rules. Results of the promotion are final in all respects. The promotion is subject to all federal, state and local laws, rules and regulations. Void where prohibited by law. Odds of winning depend on the number of eligible entries received.

**SWEEPSTAKES DESCRIPTION:** Solarity Credit Union is rewarding members who use their Solarity debit card throughout the month of April with multiple opportunities to win weekly prizes as well as one of three grand prizes. Each debit card purchase made from an eligible Solarity Credit Union personal checking account during the Sweepstakes Period is an entry into the drawing.

**PRIZES:** Sweepstakes Sponsor will award Prizes described as follows:

- Grand Prizes - there will be three (3) Grand Prizes awarded at the end of the Sweepstakes Period: a) a \$1,500 gift card (or cash equivalent) to The Coeur d'Alene Resort, b) a \$1,500 gift card (or cash equivalent) to Great Wolf Lodge Water Park in Centralia, WA, and c) a Traeger wood pellet grill (valued at \$750). Limit one grand prize per household.
- Weekly Prizes - Prizes will be awarded weekly ranging in value from \$25 to \$250: a) Week 1: seven (7) \$25 cash prizes and one (1) Solo Stove Bonfire 2.0 valued at \$250 (or cash equivalent); Week 2: seven (7) \$25 cash prizes and one (1) Nespresso Vertuo coffee/espresso machine valued at \$219 (or cash equivalent); Week 3: seven (7) \$25 cash prizes and one (1) Yeti Roadie 24 Hard Cooler valued at \$250 (or cash equivalent). Limit one Weekly Prize per household per week.

**SWEEPSTAKES PERIOD:** The Sweepstakes begins Monday, April 1, 2024, and ends on Tuesday, April 30, 2024.

**ELIGIBILITY:** The Sweepstakes is open to all U.S. residents who successfully fulfill the requirements of entry and who are at least eighteen (18) years of age. See the "Restrictions" section in these Official Rules for any eligibility restrictions. By entering this Sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of Solarity Credit Union.

**PARTICIPATING LOCATION:** The Sweepstakes is offered at Solarity's location listed in the Sweepstakes announcement. No other Solarity locations are participating in this Sweepstakes.

**HOW TO ENTER:** There are two ways to enter:

- Method #1 Use your Solarity debit card to make purchases. Receive one entry for every purchase made with your Solarity debit card from your Solarity personal checking account during the Sweepstakes Period. Only purchase transactions made with a Solarity Credit Union debit card for an account that is in good standing (both at time of entry and winner selection) and issued by the Credit Union to an eligible cardholder are eligible for automatic entry. No other transactions



are eligible including purchase transactions involving account adjustment transactions/returns, international transactions, late payment fees, over-limit or over-draft fees, return check fees, check re-order fees, ATM fees, cash advances, monthly/annual fees, balance transfers and/or other fees assessed on your account are not eligible for automatic Sweepstakes entry. Entries from unauthorized card use or those made with lost, stolen or fraudulent cards are void.

- **Method #2: Alternate Method of Entry ("AMOE").** To receive one entry into the Sweepstakes without having a Solarity checking account or debit card, print your full name, complete home address, email address, phone number, age and "April Get-Away Give-Away" on a 3 x 5-inch piece of paper. Send it by United States mail in a sealed envelope no larger than 9 ½" x 4 ¼" (a #10 envelope) with correct postage to: April Get-Away Give-Away Sweepstakes, ATTN: Marketing, PO Box 2922, Yakima, WA 98907. Each Mail-In Entry must be mailed separately and must be postmarked between Monday, April 1, 2024, and Tuesday, April 30, 2024, and received by Monday, May 6, 2024. Photocopied, illegible or mechanically reproduced entries are not eligible. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

All methods of entry have an equal chance of winning. All entries become the sole property of the Sponsor and will not be acknowledged or returned.

**WINNER SELECTION:** Weekly Prize Winners and Grand Prize Winners will be randomly selected from among all qualified entries submitted during the Sweepstakes Period. Weekly Prize Winners will be determined and notified April 8, 15 and 22, 2024; Grand Prize Winners will be determined and notified on May 7, 2024. Individuals need not be present to win.

**ODDS OF WINNING:** The odds of winning depend on the total number of qualified entries submitted. Sweepstakes Sponsor will notify the Prize Winners personally by telephone, email or postal mail using the contact information supplied within the Sweepstakes Entry. It shall be the responsibility of entrants to provide contact information within their Sweepstakes Entry in order to be eligible to collect the prize. Entrants may be asked to provide proof of eligibility to enter.

**NO TRANSFER OR SUBSTITUTION:** No transfer or substitution of prizes by Prize Winner is permitted. All federal, state, and local taxes, if any, are the sole responsibility of the Prize Winner. Prize may be subject to Internal Revenue Service Form 1099 reporting. Winner must claim his or her prize within seven (7) business days of being notified by Sweepstakes Sponsor or entrant will be deemed to have forfeited his/her prize. Should a prize be forfeited, an alternate winner will be chosen from the remaining eligible entrants in a separate random drawing conducted by Sweepstakes Sponsor.

**RESTRICTIONS:** Members of the official family of Solarity Credit Union, defined as directors, officers, volunteers and employees of Solarity and its affiliates, and their immediate family members and persons residing in the same household, are prohibited from participating in any Solarity-sponsored Sweepstakes, drawings or prizes and are not eligible to enter or win.
