



INSTANT WIN PRIZE BOARD OFFICIAL RULES

Solarity Credit Union's ("Credit Union" or "Sponsor") Instant Win Prize Board ("Sweepstakes") is governed by these Official Rules. By participating in the promotion, each entrant agrees to these Official Rules. Results of the promotion are final in all respects. The promotion is subject to all federal, state and local laws, rules and regulations.

If the number on the scratch off ticket matches a number listed on the prize board, instantly win the prize associated with that number. WINNER SELECTION: Prize winners will be determined daily during the Sweepstakes Period based on the numbers that are uncovered on the scratch off tickets.
